- 4. Information reasonably sufficient to permit GEORGIA PROSTHODONTICS SMILE SPECIALISTS to contact the complaining party, such as an address, telephone number, and, if available, an electronic mail address at which the complaining party may be contacted;

Upon receipt of a valid notification of alleged copyright infringement by a third party, GEORGIA PROSTHODONTICS SMILE SPECIALISTS shall remove or disable access to the material identified in the notice, forward the written notification to the alleged infringer, and take reasonable efforts to notify the alleged infringer that it has removed or disabled access to this material.
